1.0. INTRODUCTION

The National AIDS Commission (NAC) guided by the HIV and AIDS (Prevention and Management) Act 2018 is responsible for provision of leadership, technical guidance, and coordination of the National Response to HIV and AIDS in Malawi. The broad objectives of the Commission are to (i) provide leadership and enhance management and administrative systems to support implementation of the National HIV and AIDS Strategic Plan (NSP); (ii) Strengthen multi-sectoral and multi-disciplinary coordination and implementation of HIV and AIDS Programs and (iii) Strengthen monitoring and evaluation of the national response to HIV and AIDS.

The National AIDS Commission (NAC) receives funding from the Government of Malawi and from various funding partners towards the implementation of the Malawi National HIV and AIDS Strategic Plan (NSP) and applies part of the funding for the procurement of consultancy services for the NAC secretariat and its stakeholders.

2.0. OBJECTIVE OF THE ASSIGNMENT

The National AIDS Commission wishes to compile a database of consultants for the provision of various consultancy services as shown below for its use for the next 3 years.

3.0. REQUESTS FOR CONSULTANCY SERVICES

It is against this background that the National AIDS Commission would like to invite expression of interest from reputable firms or individuals whose consultancy services will be engaged for specific periods and when need arises, to assist them in providing technical expertise on issues being considered by the Commission. Interested Consultants are free to express an interest in a maximum of two categories.

- vi. Prepare research papers relevant to the subject matters under consideration at any particular time;
- vii. Produce draft and final acceptable reports in consultation with the relevant Contract Administrators
